GENERAL EXCURSION PERMISSION FORM

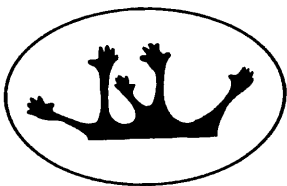
I, hereby give permission for my child/children to attend the local excursions being organised by the Toorloo Arm Primary School during the year.

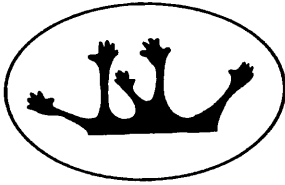
I understand that from time to time, the school may wish to publish examples of student projects, photographs of students, and other work on an Internet accessible WWW server of printed media.

USE OF PRIVATE CARS FOR ANY SCHOOL EXCURSION

All drivers of private vehicles are to READ the following conditions carefully.

- The vehicle must be fully REGISTERED and ROADWORTHY.
- The driver must hold a current DRIVER'S LICENCE.
- The vehicle must be fully covered by THIRD PART INSURANCE.
- The vehicle must be fully covered by COMPREHENSIVE INSURANCE that includes liability at law by way of damages to an amount of not less than \$200,000 and an indemnity to the Crown (Drivers should check the details of their Comprehensive Insurance to ensure full cover).
- The number of passengers must not exceed the number of SAFETY BELTS fitted.
- The parents of passengers have the right to refuse permission for their child/children to travel in a particular private car.
